You, the applicant have applied for membership of MSAC. In consideration of your application for membership being accepted (which it may not be in MSAC's absolute discretion and without giving reasons) you acknowledge and agree that: This membership is for a contracted period of 12 months.

MSAC Club General:

1. The annual membership fee is payable up front, in full and is non refundable.
2. No suspensions are available on memberships.
3. Lost membership cards must be reported to MSAC. Replacement membership cards are available for \$15.00.
4. You may purchase credit of any monetary value to be added to your membership card.
5. Credit can be used at any point of sale desk within MSAC for selected products, for more information please refer to a customer service officer.
6. Credit is valid for the duration of your membership and any unused credit will be forfeited at the time of membership expiry. If membership is renewed within one month of its expiry, any remaining credit will be carried over to new membership.
7. Casual visit passes can be purchased for Aquatic and Health and Wellness access. Passes are non refundable and visits will be valid for 12 months from the date of purchase. Refer to casual access conditions for more specific area information.

Casual Aquatic Access:

1. Passes are transferable, however passes cannot be used for large group discount.
2. Concession cards must be produced at the time of purchase if eligible for a concession discount.
3. Swim passes provide access to pools ONLY. An additional fee is required for spa, sauna and steam room or to participate in an aquatic class.
4. Access to the Competition Pool and outdoor pool is subject to events and bookings. For more information, pick up a Lap Guide from reception; call the Lap Lane Hotline on 9926 1630 or visit our website: www.msac.com.au

5. Children under 10 years of age must be accompanied by an adult over sixteen years of age, and accompanied in the water when the wave pool is operating.

Casual Health and Wellness Access:

1. Passes are transferable.
2. One visit constitutes the card bearer access to either:
 - 2.1 The Wellness Zone (This may include one or all of the following: a group training class, massage or hydro session). Or
 - 2.2 The Fitness Centre (This may include one or all of the following: group training class, gymnasium visit, aquatic visit)
3. MSAC Club members may book appointments for the Power Plate, or program prescription for an additional fee payable at the member liaison desk.
4. Warning - Undertaking exercise can be inherently dangerous. You acknowledge that you are exposed to certain risks whilst undertaking exercise including but not limited to physical exertion, body contact ground or venue contact, venue conditions, exercise associated items and equipment and fixed venue items.
